Summary Annual Report for Southwest Carpenters

Health and Welfare Trust

This is a summary of the annual report for Southwest Carpenters Health and Welfare Trust, Employer Identification Number 95-6042873, for the calendar year 2012. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees has committed itself to pay certain hospital-medical, prescription drug, and death benefit claims incurred under the terms of the plan.

Insurance Information

The plan had contracts with Anthem Blue Cross Life and Health Insurance, Select Health, United Healthcare Insurance Company, Kaiser Foundation Health Plans Inc., Health Plan of Nevada, Sierra Health and Anthem North Nevada, to provide prepaid medical, dental and hospital services. The total premiums paid for the plan year ending December 31, 2012 were \$184,229,557.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$(5,659,634) as of December 31, 2012, compared to \$(35,079,690) as of January 1, 2012. During the plan year, the plan experienced an increase in its net assets of \$29,420,056. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$269,358,728, including employer contributions of \$255,729,310, participant contributions of \$10,027,811, realized gain of \$2,236,453 from sale of assets, earnings from investments of \$768,306, unrealized loss on assets held of \$949,232, and \$1,546,080 in other income.

Plan expenses were \$231,922,151. These expenses included \$223,241,084 in benefits paid to participants and beneficiaries and \$158,506 in interest expense and \$8,522,561 in administrative expenses. During the plan year, the plan returned \$8,016,521 to Southwest Carpenters Vacation Trust.

4. Transactions in excess of 5 percent of plan assets; and,

If you request a copy of the full annual report from the plan administrator, these two documents and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

Fremont Avenue, Los Angeles, California 90071, and at the U.S. Department of Labor in Washington, D.C. or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
