This is a summary of the annual report for Southwest Carpenters Health and Welfare Trust, Employer Identification Number 95-6042873, for the calendar year 2014. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees has committed itself to pay certain hospital-medical, prescription drug, and death benefit claims incurred under the terms of the plan.

Insurance Information

The plan had contracts with Anthem Blue Cross Life and Health Insurance, United Healthcare Insurance Company, Kaiser Foundation Health Plans Inc., SelectHealth, Anthem Blue Cross Dental and Life Insurance Company, Voya Financial, Liberty Dental, BETA Health Group, Delta Dental of California, United Healthcare Dental, Total Dental Admin., Health Plan of Nevada, Sierra Health, and Anthem North Nevada, to provide prepaid medical, dental and hospital services. The total premiums paid for the plan year ending December 31, 2014 were \$221,603,399.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$(42,255,526) as of December 31, 2014, compared to \$(4,025,222) as of January 1, 2014. During the plan year, the plan experienced a decrease in its net assets of \$38,230,304. This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$229,286,815, including employer contributions of \$222,575,464, participant contributions of \$5,690,719, realized gain of \$48,991 from sale of assets, earnings from investments of \$1,568,590, unrealized loss on assets held of \$(1,028,800), and \$431,851 in other income.

Plan expenses were \$267,517,119. These expenses included \$259,378,649 in benefits paid to participants and beneficiaries and \$8,138,470 in administrative expenses.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
