SUMMARY ANNUAL REPORT

December 31, 2019

This is a summary of the annual report for Southwest Carpenters Vacation Trust, Identification Number 95-6042279 (Plan 501), for the plan year ending December 31, 2019. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees has committed itself to pay all vacation benefit claims incurred under the terms of the plan.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$8,901,004 as of December 31, 2019, compared to \$5,876,483 as of January 1, 2019. During the plan year, the plan experienced an increase in its net assets of \$3,024,521. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$230,225,797, including employer contributions of \$227,331,651, realized gains of \$47,321 from sale of assets, earnings from investments of \$2,465,678 and \$381,147 in other income.

Plan expenses were \$227,201,276. These expenses included \$223,896,487 in benefits paid to participants and beneficiaries and \$3,304,789 in administrative expenses.

If you make a written request for certain documents, the plan may impose a reasonable charge to cover the cost of furnishing those documents, provided the least expensive means of reproduction is used. You also have the right to receive from the plan administrator, on request and at no charge, a statement of the assets and liabilities of the plan and accompanying notes, or a statement of income and expenses of the plan and accompanying notes, or both. If you request a copy of the full annual report from the plan administrator, these two documents and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
